

Hendricks Regional Health EMS Education 2025 EMT Course Information

Thank you for your interest in the Hendricks Regional Health Emergency Medical Technician (EMT) program. Hendricks is offering (3) EMT courses in 2025 – two traditional programs and one accelerated program.

Dates and Hours

Spring (Traditional): January - June with classes Mondays and Wednesdays from 6:00-10:00 p.m. Summer (Accelerated): June – July with classes on Mondays, Wednesdays and Fridays 9:00 a.m. to 4 p.m. Fall (Traditional): June - December with classes Tuesdays and Thursdays from 6:00-10:00 p.m.

Enrollment

Program enrollment has first come, first serve entry for the first (20) applicants in each cohort to complete the application process *and* submit a tuition deposit. If more than (20) complete applications are submitted, a waiting list will be initiated.

Applicants must first complete a course application, found here:

Applicants must then submit copies of the following documents:

- ✓ Driver's License or Government Identification
- ✓ High School Diploma or Education Certificate
- ✓ Indiana Limited Criminal History Report (https://www.in.gov/ai/appfiles/isp-lch/)

Successful completion of the course fulfills the requirements needed to sit for the National Registry of Emergency Medical Technicians written examination for EMT certification and state Emergency Medical Technician Psychomotor Skills Examination.

Tuition

The cost of the traditional (Spring or Fall) program is \$1,050.00 with a \$500.00 deposit due to reserve your seat in the program. The remaining balance must be paid within (30) days of the beginning of the course.

All accelerated course students must pay the \$1,250 tuition in full to reserve their seat in the program.

Tuition includes CPR Certification through the American Heart Association, course textbook, access to online course material with clinical scheduling and skills tracking, and (2) uniform shirts needed for clinicals.

Additional Costs

- ✓ Students will need to provide their own navy blue or black work pants and black, close-toed shoes or boots to wear during their field clinicals.
- ✓ The National Registry of Emergency Medical Technicians online written examination application fee is \$104.00 and will be required to sit for the certification exam upon successfully completing the program.

Clinical Experience

In addition to class lectures, during the program students will complete a minimum of (36) hours of field internship clinicals with one of our sponsored fire departments.
